Financial Report: Doug is moving out of GACC boundaries. Sue thanked him for his service Cash on hand \$11,975.03. YTD loss \$357.81. Biggest expenditure to date was \$387 paid to Blind Owl for WTS meeting.

Election of New Treasurer: Jason made a motion and Joe seconded to nominate Gigi for Treasurer. No discussion. Gigi said she would do both Secretary & Treasurer. Gigi does not have QuickBooks. Doug's copy belongs to his dog club so GACC would need to purchase its own copy at \$200-\$300 or create some kind of ledger. Motion made & seconded to elect Gigi to treasurer. Passed unanimously. A second motion (by Don) to purchase QuickBooks. **This was never seconded or officially voted on**. Doug & Gigi will work out details of transferring financial info to Gigi. Doug thinks he will close on Daleville property between July 15-30 so he will remain until at least the 15th. He was agreeable to being available via ZOOM if questions arise.

Dan arrives. Ted advised that meeting is recorded and that Gigi elected treasurer.

Sue: Received email from George of BRAG who wants to revisit a land use committee comprised of BRAG and GACC representatives. Ziebart on 86th St. closing across from Costco. Property not for sale. Hoping for a new tenant. Wants to try to get together on June 23, 24, or 25th. Ted: Existing bylaws allow board to establish committees which may or may not include board members. Need a group that has the ability to fundraise and to "pull out a big hammer" when we need it. Dan: need a "Community Development Corporation" to take over Castleton Plan initiative. Raise \$\$ to promote & market. Include businesses from Merchants Association. BRAG has individual and business memberships to offset expenses. Bill McAllister contracted by BRAG to increase memberships. Dan thinks we need a "true zoning" representative. Ray Brinkmeyer from Avalon Hills, retired zoning lobbyist wants to get involved with Castleton plan. Motion made in accordance with Article 6 to form a committee to liaise with BRAG in context of Castleton Revitalization. Seconded and passed unanimously. Andy & Ted offered to join with BRAG on this committee. It was suggested that Jason join this also.
