Ted - Nickle Plate goes through a lot of neighborhoods. Don mentioned that not everyone in support.

Sue said need to recognize Castleton revitalization and see ben

Sue: need to determine fair amount for business and neighborhood assoc.

Don: if a neighborhood association joins does that mean their residents are also members. NO.

Reports from Local Officials:

Dan Boots, City Councilor

- News about Nickel Plate. Confirmed DPW has access to \$4.2 mil to match \$5 mil. from grant (if we are awarded) to get the basics: designs, all drainage, and construction.
- B&O RR trail on west side. Was awarded in 1st round but we got in 2019 political firestorm. Think NP should now be on top of stack for consideration. Hope to get greenlight 3-6 months for NP.
- \$13 mil covid money for rental assistance & other categories
- Not sure Indy or Marion County will be considered in next round.
- Only Indy city granted \$168 mil. Directly state distributed other money
- Food commission to coordinate food relief agencies across county. Have Indy Hundred network now, but this will directly help with food distribution and deserts
- Indy neighborhood infrastructure projects. City matches funds. Applications through Jan 29 for neighborhoods to rebuild sidewalks, bridges, etc. #1 complaint is sidewalk construction.
- Crime prevention Dollar Tree at 75th and Shadeland. City given allotments to each district and district \$1.25 mil to be distributed "equitably" across 25 districts. 2 groups did study rated each district by crime. Dist. 3 one of the safest so we won't get much money. 4 tiers 80k 60k 40k 20k. Dan sent survey on crime prevention. Only got about 15 responses so will send back out.
- Lack of security videos in city. Dan victim of smash and grab at Panera. No video. Vieo successful crime prevention tool. Europe has video every block. USs needs to enhance lighting video surveillance.
- We pay interventionists. We pay to talk to talk to family to deter further crime. Not our type of crime here
- 501c3 to receive and to through hoops to receive public money.
