Dan Boots wrote letter requesting continuance. New date July 20, 2021. Dan meeting with Simon to discuss.

Andy: Krispy Kreme wants to keep branding with shape. In line with their other signs. Construction started.

The problem is the distance from main Castleton sign is less than required 300 ft. With location Krispy Kreme sign never can be if located on their property. Mo concerned that this variance will set precedent for future sign requests. Sign much smaller than allowed.

Don mentioned that Dan's letter stated he was working with BRAG, not GACC. He counted approximately 20 yard signs between Allisonville and Hague along 82nd St. Thinks that may be the beginning of deteriorating neighborhood, GACC will take no action at this time and let Dan's letter "run its course".

- 190 creates permanent sustainability committee
- \$125 mil for road improvement. \$1.1 mil in district 3. Dan drove all streets in District 3. DPW will review Dan's recommendations and make decision.
