4720 Kingsway (empty building with chain link fence) has had break ins (not in our area). Neighbors concerned about safety. Feeder trails to NPT are being planned, e.g., from Eastwood Middle School to NPT.

Howland Greenway (currently Ditch). Want to clean it up and turn into Greenway. Being studied.

Budget introduced Monday. Details should come up in the news. Contains a focus on DPW and infrastructure.

Election coming up on November 7. Make sure you are registered to vote!
