2023-UV3-022 CF Laughner (Auto Repair/Sales) 8345 Bash St. Jan 16, 2024

1 acre zoned C4 for repair. Drainage. Client is gifted auto mechanic. Wants variance C5 for auto sales to help sustain business. May rent space for financing, etc. Space for 19 Cars along Bash. Have letters of support from nearby businesses. Sent out 90 notices & have not received negative. 8am-8pm no Sunday. Mostly by appointment. Concerns about long range plans for Castleton Revitalization.

Landscaping plans?? No plan yet, but there will be one.

Don moved to support, Ted second. Unanimous approval.

GACC Discussion: NPT is elevated at that point. Repair shop going in. Per Dan we should seek specific commitments. Petitioner has big incentive to meet commitments. Originally continued due to not getting info out. Drainage? landscaping, buffer along Bash.

Don motioned to ask for continuance Ted seconded to request continuance so we can go back to petitioner with questions for a more accurate site plan, drainage, bays to rear, car sales to rear.

2023-MOD-022 Uptown Cheapskate 5151 East 82nd St. Jan 25 2024, (Joe Calderon & Dakota from Clearwater). National 2nd hand concept. Small portion of consignment and luxury brands. No drop off like Goodwill, Salvation Army. Joe talked to someone from Broadbent who was concerned that this would eliminate restrictions. This is a modification. 2nd hand is more sustainable. Space is 5000 sq. ft. Store one in Cincinnati.

2023-DV3-038 Raising Cane 8245 Allisonville Rd (former Lifeway Christian Store) Jan 14 (Joe Calderon & Felicia from Raising Cane). Also inside dining. 27 parking spaces (26 required). Business has shifted to more drive through, not eat in. Inside decorating tailored to local schools, etc.

Double stacking lanes for drive through. Entrance shifted to east to keep stacking within parcel. 32 stacking places, double usually needed for peak hours. Manager can go to single lane at discretion. Last year donated \$125 million to many organizations. Kevin (Brag) -DISCREPANCY On SITE PLAN. Dan asked about commitment to maintain landscape. Joe said that is part of the ordinance. Per Dan if part of code it is harder to enforce than if part of commitment. Signage supposed to be 300' apart. Felicia said the signage may be part of main sign. Per Dan cannot just replace existing sign due to codes.

Troy has visited Noblesville location and it is good. Concerns about double stacking and if approved we are afraid set precedent. If we oppose, there are lots of other locations they could go to. Troy thinks we should be pleased they want to locate in Castleton.

Andy moved to support, Don second. Passed Unanimously. Need be specific commitments. Andy support with proposed commitments regarding landscaping provide accurate plans.
