Dan Boots: Bridges for NPT going ahead. Soccer stadium – not sure. Dealing with Pacers for shared parking garage since games won't be scheduled at same time. Sue mentioned that a client told her that they wouldn't buy in Marion County because the bad roads. Dan said car tax could be raised. \$50 million per year to match state. May enact delivery tax. Instead of 'road' miles may go to 'lane' miles, benefitting Marion county.

Indianapolis Education – Charter schools are trying to get Marion county education \$\$\$. Trine University is attempting to take the Marion County market.

Nick Roberts: still working on road conditions. Has asked for certain road improvement projects. Federal projects impacting Indianapolis. April 19, hosting a clean up around Castleton Square Mall. Sears development – Hobby Lobby and another store may go in.

Great North Run partnered with a clean-up along Keystone. Mo thinks it should be replicated in other areas.
